

Academic Forgiveness in DARS

Purpose: Remove courses (course, count, and GPA affect) from a student's program when academically forgiven.

Academic Forgiveness in DARS requires encoding in

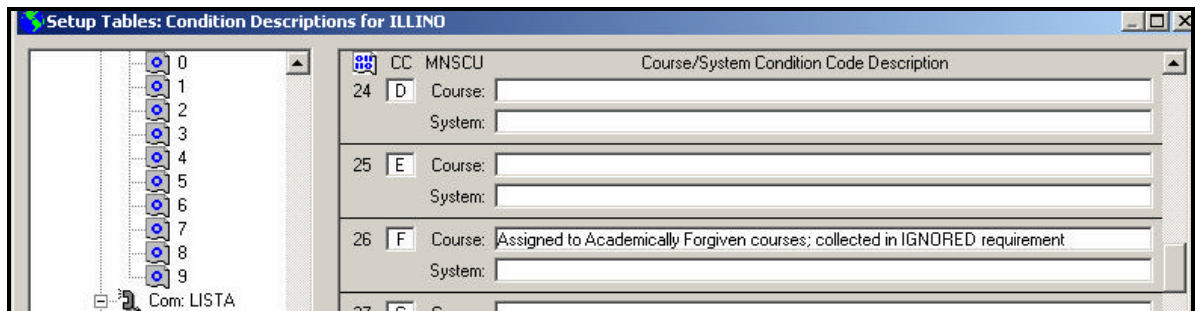
- Setup Condition Description
- Setup Exception Rule
- Exception on student in Joe Cool

Additionally,

- Setup Requirement, identifying Academically Forgiven courses

Setup Condition Description

Select a course Condition code value, and define in your Condition Code Description table.



Setup Exception Rule

Create an Exception Rule for ignoring courses that are academically forgiven.

AF ("AF" is user defined) has an Add Count of <0>, and an Action of <S> (course substitution).

Under the “more” button, GPA Calculation is set to <“>, Not used in GPA calculation; Add Credit is set to <“>, No Credit assigned; Add Count is set to <0> zero; and Delig is set to <+>, Allow Substitute.

Note: Academically forgiven course numbers generated through TA processing (e.g., ELETT***, in this example), **must be locked in Transfer Evaluation.**

This process will remove the academically forgiven course from the audit. However, if you wish to display the AF course on the audit, you will need to create a requirement to collect AF courses.

The Required sub-requirement flag is set to <X> Optional – Will not count toward REQRQ.
